Objectives:

This module examines the political, religious, ideological, social, economic and strategic forces that inform the allocation of power and resources in Israeli society and its political decision making processes. While a historical perspective is frequently adopted, this is not a course on the history of the state; rather, an understanding of the processes of state formation and securitisation is used to inform discussion of aspects of Israel today and conceptions of 'Israeliness'. Further, this is not a course on the Israel/Palestine dispute, the justice of the Palestinian or Israeli cause or the various processes of resistance, occupation and peace initiatives. Instead, the Israel/Palestine dispute is recognised as an important aspect of the context in which Israeli society is examined and Israeli identity discussed.

Seminar 1. Interpretations of Zionism

Seminar Question: How can we best distinguish the various strands of Zionism and their contribution to state formation?

The discussion: this discussion requires an understanding of the breadth of pre-state argument about the need for a Jewish state and the form that it was to take; this approach examines the Zionist enterprise as a process of construction of multiple Zionist political ideologies in the context of the creation of the state; this leads to an awareness, early in the course, of the ongoing debates about the organisation of Israeli society. Zionism is understood to provide a clear ideology designed to legitimise a sovereign Israeli state but lacking clarity about the essential features of the state, particularly the role of religion and the ultimate geographical borders.

Seminar 2: Ethnicity

Seminar Question: To what extent is ethnicity uniting or dividing Israeli society?

Discussion: the discussion considers the ethnic divisions in Israeli society and Israel's management of immigration and social cohesion; the topic requires an understanding that Israeli ethnicity is about more than Israel/Arab and the topic links to a discussion of Zionism as a unifying ideology under pressure from waves of immigration of Jews of differing ethnicity and culture.

Seminar 3: Religion

Seminar Question: How important is religion to the organisation of Israeli society? To what extent is Israel's settlement policy a religious project?

Discussion: the discussion of Zionism will have introduced the secular/religious tension underlying the relationship between Judaism and the State. This topic requires an understanding of the differing secular and religious lifestyles and the political compromise that gives the orthodox Rabbis control over some aspects of the Israeli personal space. The discussion will also examine the position of the orthodox religious groups on territorial compromise, settlement and their growing influence in the IDF.

Seminar 4: Israeli Arabs

Question: What is the position of Israeli Arabs? Is membership of an Islamic party incompatible with Israeli citizenship?

Discussion: this is intended to build on the understanding that Israeli Arab citizens have full citizenship rights and are not to be confused with Palestinian residents of the Occupied Territories. The discussion considers the relative deprivation of the Arab community, the complexity of an Arab identity in Israel and the growing influence of Islam to ask whether Israeli Arabs can ever be considered 'equals'

in a Jewish State.

Seminar 5: The Electoral System, Parties and Civil Society

Question: With particular reference to the 2009 election, does proportional representation help or hinder the process of democratic government in Israel? Is ethnicity a reliable guide to political affiliation?

Discussion: students will by now be aware of the religious and ethnic divides and will be

expected to discuss whether the Israeli electoral system correctly balances the need to

represent these various groups with the requirement for efficient government. Students

should demonstrate an understanding of the multi-party system, coalition government and the thriving civil society of NGOs and interest groups.

Seminar 6: The Military and the State

Question: Do the people control the army or does the army control the people?

Discussion: students will be aware of: the conscription system, the value placed on military service in all aspects of Israeli life, senior members of the military 'parachuting' into politics and the links between the military and the economy but will also be aware of the submission of the military to civilian government control. The discussion invites opinions on the institutional, cultural and sociological implications of a civilian army facing continuing threats to the security of the state.

Seminar Topic 7: The Political Economy of Israel

Question: Why was state direction of the economy considered essential in the first two decades of the state? How can the Haredi community be integrated into a modern economy?

Discussion: students will be aware of Israel's economic miracle and the experiences of the ethnic groups on arrival in Israel. This topic examines the role of government control of the economy in state formation and the liberalisation process of the last 30 years, exposing the tension between Zionist ideals of economic strength, social justice and provision for *olim*. This raises questions about the sustainability of the economy and the policy implications of the reduced participation of the Arab and Haredi communities in the modern economy.

Lecture 9: Israel's Foreign Relations

Seminar Topic 8: The Legacy of the Holocaust

Question: To what extent does the experience of the Holocaust influence current Israeli behaviour in the public space? How has the relationship between the state and the survivors and their families changed over time?

Discussion: The discussion builds on an understanding of the effect of the Holocaust on the processes of immigration in the immediate aftermath of WWII, to explore the treatment of survivors and their families and consider the extent to which Israeli society has internalised an extreme form of self-reliance, distrust of alliances and a tendency to view all threats as existential.

Lecture 10: Conclusion: The Post-Zionist Debates

Seminar Topic 9: Israel's Foreign Relations

Question: 'America's strong bonds with Israel are well known. This bond is unbreakable. It is based upon cultural and historical ties, and the recognition that the aspiration for a Jewish homeland is rooted in a tragic history that cannot be denied.' (Barak Obama). Is this a persuasive description of the relationship?

Discussion: this topic demands a considered appraisal of the relations between Israel and the US that critiques the Mearsheimer/Walt position to make an informed assessment of the strength of the alliance and the factors that account for its endurance. While students will demonstrate an awareness of the strength of the American Jewish lobby, the counter-arguments require careful assessment. Seminar discussion can usefully be organised around pro and anti Mearsheimer/Walt positions.

Lecture Topic: Discussion of the Exam

Seminar Topic 10: The Post-Zionist Debates

Question: To what extent can Israel be described as 'Jewish and Democratic'?

Discussion: The topic explores the themes of the course to comment on Israel's view of itself as revealed by the small group of thinkers who challenge Zionist orthodox conceptions of a 'Jewish and democratic state' in favour of an Israeli 'Hebrew' identity. The discussion raises questions about the character of Israeli democracy and whether Zionism is capable of producing an Israeli consensus that can locate the final borders of the state.
