The state of Israel, now just over sixty years old, represents in many ways an extraordinary success story: a revival of Jewish political sovereignty after nearly two millennia of statelessness; a dynamic economy with more startups per capita than any other country in the world, attracting as much venture capital as France and Germany combined; a vibrant, multicultural society with an astonishingly diverse population. But it's no secret that Israel is also the subject of increasingly bitter controversies—perhaps the only state in the world today whose very legitimacy is contested, and whose final borders have yet to be drawn. The long conflict between Israelis and Palestinians, which seemed to be on a track toward resolution only a decade ago, now seems to be insoluble within the foreseeable future. Meanwhile, there are stubborn internal conflicts as well: unresolved problems in defining the relationships between Judaism and the state, between its religious and secular inhabitants, and between the Jewish majority and non-Jewish minorities.

Our course aims to illuminate both sides of this story: the amazing achievements of this new state, and its frustrating failures to resolve basic conflicts with its neighbors and persistent tensions within Israeli society. The course begins with an analysis of the Zionist movement and its founders, examines the origins and development of the conflict between Zionist settlers and a nascent Palestinian nationalist movement, traces the causes and consequences of each of the wars Israel has fought, and explores the major political realignments that have occurred since the state's founding in 1948. The course also examines the nation-building process and the distinctive features of Israeli democracy; the transition from the visionary socialism of the founders to the high-tech capitalism of today; and—from a variety of perspectives—the failure of the peace negotiations that began in the 1970s, peaked in the 1990s, and failed so disastrously in 2000.

For students in search of answers to what is possibly the world's most intractable conflict, we cannot hope to offer a definitive account in ten weeks. But we can explore the conflicting "narratives" of the two sides, drawing on a variety of sources and, in particular, memoirs, essays, and fiction by some of the most gifted Israeli and Palestinian writers. SUGGESTION FOR THE FIRST PAPER:

(six pages, due April 30)

- 1. We are reading two wonderful memoirs this quarter, Amos Oz's *A Tale of Love and Darkness*, and Sari Nusseibeh's *Once Upon a Country*. The two men are friends, and each admires the other's work. The challenge of the first essay is to compare their accounts of their childhoods. How does each writer map the connections between the history of his people and that of his family? Which portraits of family members are especially memorable, and why?
- 2. Every great autobiography is among other things an account of an education. What kinds of educational experiences do Amos Oz and Sari Nusseibeh describe? What are the similarities and differences between them?
- 3. As Sari Nusseibeh reminds us, he and Amos Oz lived within a mile of each other in Jerusalem, but their experiences of the city were bound to be very different. Compare Oz's Jerusalem with Nusseibeh's, and illuminate some of the reasons for those differences.
- 4. Both memoirs deal with the theme of loss. What are the principal losses for each writer, and how do those losses illuminate larger historical themes?
- 5. How does each writer describe and respond to his first encounters with the other side? How does each deploy humor, irony, and/or empathy in his descriptions of early encounters with Arabs (in Oz's case) or Jews (in Nusseibeh's)?
- 6. One of the pleasures of reading Oz and Nusseibeh is that they have cosmopolitan imaginations: even as they are intensely involved in their own cultures, they have powerful ties to the legacy of Western (European) culture as well. How does their cosmopolitanism enrich their experiences of Israel/Palestine?

Addendum: News Sources

Israel is about the size of New Jersey, but as we know very well it receives more media attention than New Jersey does. The best way to get news on a particular event is to sample several sources. The following list of sources is anything but comprehensive:

Haaretz: Israel's newspaper of record. Has a left-of-center orientation. The op-ed articles are first-rate. English version can be read on-line: www.haaretzdaily.com/

The Forward: descended from the great Yiddish newspaper, the weekly English edition has first-rate news and excellent cultural coverage.

Tikkun: edited by Rabbi Michael Lerner, who leans to the left, this lively magazine has become increasingly critical of Israeli policies in recent years. Compare with *Commentary*, the distinguished American monthly that has been leaning to the right for several decades now.

Debka: a "behind-the-scenes" website written by former Israeli security officials. Analysis tends to be "hawkish." http://debka.com

Jerusalem Post: English-language Israeli newspaper, formerly right-of-center, edited now by a liberal, David Horovitz (the author of *Still Life with Bombers*). http://www.jpost.com

Israel National News (Arutz 7): the voice of the religious settler movement. http://www.israelnationalnews.com/

Palestine News Agency: news and analysis from the Palestinian perspective. www.wafa.pna.net
